  - b) Giving guidelines to how to be judged according to the law (Numbers 35:30-31; Deuteronomy 19:11-13)

- 4. Under grace (Romans 13:3-4)
  - a) Verified under grace
  - b) Verified by the Apostle Paul (Acts 25:11)
  - c) Government instituted to be the avenger of blood (Romans 13:3-4)
  - d) Verified by the Apostle Peter (1 Peter 2:13-14)
- II. PAUL'S APPEARANCE BEFORE KING AGRIPPA (Acts 25:13-27)
  - A. The Explanation of Festus (Acts 25:13-21)
    - i. The indecision of Festus (Acts 25:13-14)
    - ii. The indignation of the Jews (Acts 25:15-16; Acts 25:1-3; Luke 23:23)
      - 1. The Roman's law required that he get to answer for himself
      - However, the Jew's law did as well (John 7:51; Acts 24:19; Deuteronomy 1:7; Deuteronomy 17:8-11)
        - a. Both parties were to stand before God, the priests and the judges (Deuteronomy 19:15-19)
        - b. Solomon had noted that no man should cast judgment until he had heard a matter (Proverbs 18:13)
    - iii. The puzzle of their accusations (Acts 25:17-18)

- Note: Questions and Superstitions (Acts 25:19)

 The danger of superstitions (1 Timothy 1:4; 1 Timothy 4:7; 1 Timothy 6:20; 2 Timothy 2:16, 23; 2 Timothy 4:4; Titus 1:14; Titus 3:9)
